REFERENCE: [redacted]-2881, dated 9 November 1963 (not sent Mexico)

1. We wish to alert Mexico Station to the probable arrival of [redacted], Czech Film Representative, who may attend the forthcoming Film Festival in Acapulco. KUBARK has maintained an interest in Subject since 1959 as a result of an amicable social relationship which developed between Subject and a KUBARK staffer, Kenneth N. Rupard. Because Headquarters believes that any further development of Subject would best be handled by Rupard in view of the social relationship, we do not intend to take any action while Subject is in Mexico. We would, however, appreciate being advised of any information which comes to the Station's attention concerning the activities and associations of Subject while he is in Mexico.

2. Headquarters has no information on the dates of the 1963 Acapulco Film Festival and would appreciate being advised whether the festival will take place as in 1962, from 24 November - 6 December.

3. For [redacted] If Rupard has no reservations about personally corresponding with Subject, we suggest that he send greetings to Subject per para 3 (g) of reference.
