1. Attached you will find a transcript of several calls to Subject. These are being forwarded in this manner to signal Headquarters special attention to several items.

a. For some time there have been a number of conversations between the [redacted]s and [redacted]s concerning some sort of publication (possibly mimeograph) which they are in process of turning out jointly. (See 126 IN of Att.)

b. The conversation between [redacted] and his parents indicates that [redacted] is undergoing some sort of therapy for some kind of mental problems. Finally, [redacted] is attempting to go to "Berkeley" next year. (209 IN of Att.)

c. The conversation between [Charles] [redacted] and [Oscar] [redacted] <sup>08</sup> [201-227531] from Havana describing the latter's plans and health. (438 IN of Att.)

[RUSTY] [redacted] to [CHARLES] re football games being played following day and on Sunday. [CHARLES] indicates preference for Sunday as the day [SMALLS] would go to [redacted] residence and says he will pick up "those sheets, if you have them done, too." RR: Yeah, [ANITA] [redacted] was doing them today; that she told [ANITA] of [CHARLES] appreciation of work done and quoted [ANITA] as saying, 'I enjoy doing it for two reasons, 1) because I agree with everything he has to say, and the other is because I like him so much.' CS: She's a good politician. [RUSTY] then chats with [BS] some shirts she had requested someone to pick up in U.S., their getting together on Sunday, etc.

Collect ID call from [redacted] to [CHARLES] & [redacted] OS, 06  
He comments that he is working for [ELIZABETH] [redacted] and [redacted] 06  
[redacted] asks if it is the same job. He says it is--same stuff--but that work would run out pretty soon, that he would thereafter work a little while "at a printer's..."  
[CHARLES] says they got that info. by letter and asks [redacted] 06  
how about his coming here for Christmas. He says he still does not know what is going to happen, adding that he is "still hung up on [CHLOE] 06 that he is calling from the [redacted] (JEAN) and children). He mentions having talked with [DENNIS] several times recently. [CS] says they just heard from [DENNIS] that he had won "a second prize in poetry translation," for which he received twenty dollars.  
[CS] inquires with regard to the "guy you're consulting... is he any help?" [redacted] 06 comments that it helps "off and on" and [BS] asks if he's sticking with it... "Your therapy." He says he is. She urges him to give therapy a chance. He says it has helped some, adding that he had cried in two out of the four sessions; that he thinks the guy is great; that he was just sort of lonesome for [CHLOE]; 06 that analyst feels that "I have kind of dammed up and blocked up a lot of emotion which was giving me other kinds of mental problems," that he has helped some; that if he does not come for Christmas, he will probably come down around New Year's or shortly thereafter. [redacted] 06 say [DENNIS] is expected to arrive here around 16th December. [redacted] 06 says he has had some "down periods" and some "up periods." [BS] asks if he is able to function and he replies "Off and on," that at times he feels frustrated.

~~\*\*\*\*\*~~ [BS]<sup>06</sup> alludes to his housing setup and he says it is pretty good; that they are four and <sup>06</sup> may possibly be five, has worked out rather nicely. [BS] asks if he does not see the <sup>06</sup> very frequently and, when he advises affirmatively, comments that that is "very good." <sup>06</sup> And [DICK] <sup>06</sup> (ph.) has been very good too. [BS]<sup>06</sup> Oh, that's lovely. He's a lovely, lovely guy. [CS] comments that they "are all great people." <sup>06</sup> says he has been seeing a few women and has a couple of men friends... "I just don't feel that close to anybody...kind of impatient." <sup>06</sup> [BS] asks about his physical health. <sup>05</sup> comments that [ASHER] <sup>06</sup> (apparently referring to a doctor consulted by <sup>06</sup> had been in Mexico on which occasion he had dropped by <sup>05</sup> store. <sup>06</sup> expects to remain in Los Angeles until Sunday; that he drove down and will head back (for San Francisco). <sup>06</sup> also comments that "I have just written MAURICE (HALPERIN) a long letter" (apparently dealing with possibility of work); that there is a "really good place in Berkeley" next year. [BS]<sup>06</sup> wishes him a happy Thanksgiving, etc.

<sup>06</sup> [OSCAR] <sup>06</sup> to <sup>05</sup> [CHARLES] <sup>06</sup> & latter asks where he is calling from. [OSCAR] says he is in Havana and wants to thank [CS]<sup>06</sup> for "those lovely books you sent...one for [JUDY] and one for us." <sup>05</sup> [CS:] <sup>06</sup> That's right. <sup>06</sup> [OSCAR] mentions their appreciation and [CS] says it is a "nice way of saying hello" <sup>06</sup> [OSCAR] says he is not too well health-wise; that he has a lot of pain every day and "I'm pushing an awful lot of nitro-glycerin and other very powerful heart dialators every day," that he has very bad chest pains but that there is nothing to do; that he was thinking of possibly coming to Mexico during December but [CS]<sup>06</sup> advises against December. <sup>06</sup> [OSCAR] says he has some rather exciting possibilities on his literary work, has a movie offer on <sup>08</sup> 'Children of Sanchez,' that [MARIO] <sup>06</sup> who says he wrote screenplay for 'Zapata', is here now; that <sup>08</sup> this man wrote screenplay on [OSCAR's] book, 'A death in the Sanchez family,' that screenplay is not bad and [LUIS]<sup>06</sup> <sup>06</sup> reportedly is interested; that <sup>06</sup> wants a letter to authorize him to go ahead with 'Children of Sanchez' and asked [CS]<sup>05</sup> opinion for a lawyer.
