1. FOLLOWING FYI ONLY:

A. LNERGO REPORTED ON 13 AUG 70 THAT HENRY WINSTON (201-006887) CPUSA NATIONAL CHAIRMAN WAS TO MEET REPRESENTATIVES OF NORTH KOREAN PARTY OF LABOR DURING HIS RECENT TRIP ABROAD AND GIVE THEM DETAILED REPORT ON CPUSA POSITION RE ELDRIDGE CLEAVER (201-817097) AND BLACK PANTHER PARTY (BPP). WINSTON ASSIGNED TASK OF EXPOSING CLEAVER AND BPP AS "PHONIES" BECAUSE CPUSA WANTED TO PREVENT ANY POSSIBLE LIAISON BEING SET UP BETWEEN NORTH KOREANS AND CLEAVER. IN ADDITION, WINSTON WAS TO INFORM NORTH KOREANS THAT GROUP ASSOCIATED WITH NEW YORK CITY PROGRESSIVE NEWSPAPER, THE GUARDIAN, WAS ALSO COMPOSED OF PHONIES.

B. AT SAME TIME CPUSA FUNCTIONARY, JOSEPH BRANDT, CONFERRED WITH NORTH KOREAN PARTY OF LABOR IN JAPAN AND REACHED AGREEMENT ON STARTING AMERICAN-NORTH KOREAN FRIENDSHIP SOCIETY IN U.S.
