ON 3 AUGUST 1978 LOCAL DIRECTOR (U.S. CITIZEN) FOR BERLITZ IN MADRID CAME TO CONSULATE WITH FOLLOWING STORY: KDAFGHAN/1 (K/1) LIONION IS CURRENTLY EMPLOYED BY BERLITZ IN MADRID AND WAS ADVISED BY SPANISH POLICE THAT AS RESULT OF THE EXPOSURES BY PHILIP AGEE HE WAS TO BE THE SUBJECT OF AN EXPOSE IN THE SPANISH PRESS ON 4 AUGUST. SPANISH POLICE TOLD K/1 THAT THE PRESS HAS GOTTEN DETAILS CONCERNING HIS ACTIVITIES FOR CIA IN MEXICO CITY; THAT HE LIVED DIRECTLY IN FRONT OF THE CUBAN EMBASSY AND ACTED AS A SURVEILLANT. DIRECTOR OF BERLITZ SAID HE WAS CONCERNED ABOUT THE IMPACT THIS PRESS PLAY WOULD HAVE UPON BERLITZ, K/1 AND U.S. GOVERNMENT. HE IS TO RETURN TO THE CONSULATE ON 4 AUGUST TO PROVIDE K/1'S BIOGRAPHICAL DATA AND STATUS.
