REF A RECEIVED AFTER HSCA STAFFERS HAD ALREADY CONDUCTED INTERVIEW WITH WKSCARLET-3 ON MORNING OF 2 JUNE, ACCORDING TO POLITICAL COUNSELLOR, INTERVIEW CONDUCTED IN RE-CEPTION ROOM OF MILITARY PRISON: IN ADDITION TO STAFFERS FONZI AND GONZALEZ AND W-3, INTERVIEW ATTENDED BY ARMY CAPTAIN ON BEHALF OF PRISON AUTHORITIES.

2. WHILE GENERALLY COOPERATIVE AT OUTSET OF INTERVIEW, WHEN QUESTIONED CONCERNING ASSASSINATION ATTEMPTS AGAINST PRIME MINISTER CASTRO, WKSCARLET-3 TOLD HSCA REPS THAT HE REFUSED TO ANSWER THE QUESTIONS AS HE WAS "TOO WELL TRAINED AND DISCIPLINED",

3. EARLY IN AFTERNOON 2 JULY HSCA STAFFERS ALSO HELD BRIEF SESSION WITH WKTANGO-1. IT APPARENTLY WAS CORDIAL AND WKTANGO-1 ADMITTED TO HAVING CARRIED ORLANDO BOSCH'S (NOT WKSCARLET-3'S AS RESPORETED REF B) ADDRESS BOOK WITH HIM TO MIAMI DURING HIS RECENT TRIP.
