"1. The information furnished below has been received from usually reliable sources and consists of statements reportedly made by the de MOHREN-SCHILDTs concerning Lee Harvey OSWALD and the assassination of President Kennedy.

"a. Shortly after the assassination of President Kennedy, George and Jeanne de MOHRENSCHILDT were among the guests attending a cocktail party in Haiti. . . The de MOHRENSCHILDTs were asked if there was any substance to the view expressed in certain foreign periodicals such as <u>L'Express</u>, a left-wing Parisian weekly newspaper, that the Kennedy assassination was a plot organized by Dallas millionaires. George de MOHRENSCHILDT said that President Kennedy was hated by the Dallas elite, and he felt that it was very likely that certain reactionary elements in Dallas had organized a plot to get rid of Kennedy and used a disturbed person such as OSWALD to achieve their ends. Mrs. de MOHRENSCHILDT agreed fully with this thesis.

"3. A copy of this memorandum is being forwarded to the FBI."
