1. NO EVIDENCE TO DATE OF TRAVEL TO MEXICO BY AMPALM 26 DURING 1963.
2. FOLLOWING VOLUNTEERED BY CHIEF ODEENVY IN MEXICO, ON EVENING 13 JANUARY IN HIS ORAL REVIEW TO COS OF CURRENT PROBLEMS IN THEIR INVESTIGATIONS OF LEADS PERTINENT TO LEE HARVEY OSWALD CASE:

- A. ODEENVY HEADQUARTERS SENT CABLE TO MEXICO STATING (AMPALM/26) WAS SOURCE OF ANALYSIS PREPARED BY CUBAN PSYCHOLOGIST, JOSE I. LASAGA OF MIAMI.
- B. ODEENVY INTERVIEWED (AMPALM/26) WHO SAID: SYLVIA DURAN TOOK LEE OSWALD TO CABALLO BAYO RESTAURANT NEAR CHAPULTEPEC GOLF CLUB WHERE THEY MET CUBA AMBASSADOR TO MEXICO, JOAQUIN HERNANDEZ ARMAS. THEN HERNANDEZ ARMAS TOOK OSWALD FOR A RIDE IN HIS CAR SO THAT THEY COULD TALK PRIVATELY.
- C. (AMPALM/26) TOLD ODEENVY HIS SOURCE WAS EDUARDO BORELL NAVARRO, MEXICAN NEWSPAPERMAN WHO WRITES EDITORIALS FOR EXCELSIOR.
- D. CHIEF ODEENVY SENT MATTHEW CRAWFORD, ASSISTANT, TO INTERVIEW BORELL NAVARRO ON 12 JANUARY.
- E. BORELL NAVARRO SAID (AMPALM/26) HAD "IMAGINED" WHOLE STORY. BORELL NAVARRO SAID HE DID NOT REPEAT NOT KNOW ANY MORE THAN THAT OSWALD HAD
