- ODACID SECURITY AND NEW YORK POLICE HAVE INTERVIEWED EMANUEL ULLOA WITH FOLLOWING RESULTS: ULLOA STATES HE TELEPHONED FERNANDO BELLAUDE ON 23 NOV AND THAT COMMERCIAL CABLE MENTIONED REF A WAS FOLLOW-UP TO THAT CONVERSATION. ACCORDING ULLOA HE ADVISED BELLAUDE BY PHONE THAT DEGAULLE AND ERHARD WOULD ATTEND PRESIDENT KENNEDY'S FUNERAL AND IN CABLE SUGGESTED IT MIGHT BE OPPORTUNE FOR BELLAUDE ALSO TO ATTEND.
- ODACID SECURITY AND NY POLICE ACCEPT ULLOA'S STORY. FULL REPORT BEING MADE AVAILABLE TO KUBARK AND COPY WILL BE FORWARDED TO YOUR STATION.
