It should not be considered an organizational roster. This is merely a list of those Haitian civilians whom Duvalier appears to favor above other members of the militia. So far as the Station has been able to determine all of them should be card-carrying members of the VSN but it is possible that a considerable number are too well-known and too close to Duvalier to need such formal identification. <i>Matthew H.
