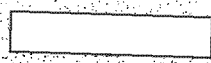
MEMORANDUM FOR THE RECORD

Subject: GREENDLINGER, Martin

1 I discussed Subject's impending arrival to the Irvine, Cal Math Conference in Sept 69, with Don Shine of the DCS (he is now in the East West Exchange Office) Specifically I asked him A) the exact name and dates of the Conference and B) current status of Subject's processing to attend this conference.

2. I advised Don that we had no operational interest in Subject as such, but that he might come to the attention of the intel community after he arrives since his case seems to be unique, i.e. an American who became a Soviet citizen and then comes out to attend a CIA sponsored International conference. Don said there were others like that, and he seemed to remember hearing something about Subject. He will check and advise.

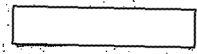

Dan will advise his own Hqs in case Subject gets his visa and shows up to the Conference.
