During 14 years I was a professor at the Central University in Quito; I left it in 1955 (September) because I was not reappointed by the council. The University is socialist led and my anti-socialist position was well known through the press.

In the period 1938-1941, I was a translator at the General Staff and a professor at the Military Academy. The Academy was closed following the Peruvian invasion of Ecuador.

For a few months in 1948, I was an official of the Secretariat of the Congress and a Secretary to the Vice-president of the Republic. I quitte it owing to a budget cut.

In 1949, I was a legal adviser to the Ministry of Public Works and I left it on December 31st owing to a budget cut.

In 1950, I was assistant to the Attorney General of the Republic. I left my post on December 31st owing to a budget cut.

From 1951 to 1954, I was legal adviser to the Ministry of Foreign Affairs. I was dismissed because I belonged to the staff of "El Comercio" and at that time "El Comercio" joined the political opposition.

In the month of September 1955, I was appointed legal adviser to the Superintendent's office, a post which I am keeping so far.

I published three books on legal subjects: "Vida del Derecho en el Antiguo Reino de Quito"; "El Caso Néstor Borja Desde el Punto de Vista del Derecho Internacional"; and "Jurisprudencia de la Cancillería Ecuatoriana". Since 1946, I have written numerous articles on legal and international topics in "El Comercio".
