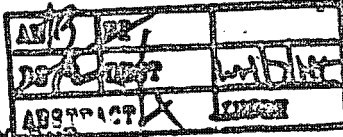

LANEOUS WEB EQUIPMENT AND ACCESSORIES FOR WEAPONS, OVER
100,000 ROUNDS AMMO. ALSO SEIZED WERE 57 BUICK SKYLARK WITH
NEW JERSEY PLATES, 66 FALCON WITH FLORIDA PLATES, TWO AND ONE
HALF TON TRUCK GMC WITH NEW JERSEY PLATES. MOTOR VESSEL
CLOWNS CITED JMWAVE 4218 WAS SEIZED AT BERTH IN MIAMI.

5. AMBASSADORS MAY BE BRIEFED RE INFO PARAS 1 THRU 4.

6. WOFAC INFO ONLY. STATION CHECKING SERIAL NUMBERS OF VARIOUS WEAPONS SEIZED. OUTBOARD MOTORS CITED PARA 3 WERE OF SILENT TYPE USED EXTENSIVELY BY WOFAC SINCE 51. MANY LOST ON OPERATIONS INCLUDING BAY OF PIGS. SERIAL NUMBERS S-21 AND S-23 ARE MEANINGLESS TO CURRENT JMWAVE STATION. APPEARS LARGE RUBBER BOAT IS RB-12 OR RB-9.5 TYPE USED BY JMWAVE. HOWEVER MANY OF THESE ALSO LOST IN VARIOUS UNDERTAKINGS SINCE 51. STATION ALSO TRACING ALL PERSONS ARRESTED. WILL ADVISE ANY SIGNIFICANT RESULTS.
