SOURCE AND APPRAISAL: FIELD REPORT NO. UFG 6307

A FORMER LATIN AMERICAN MILITARY OFFICER WHO AT ONE TIME RESIDED IN HAITI AND THE DOMINICAN REPUBLIC. HE STILL MAINTAINS FAIRLY CLOSE FRIENDSHIPS WITH OFFICIALS OF THOSE COUNTRIES. SOURCE IS A TRAINED REPORTER AND HIS INFORMATION HAS BEEN RELIABLE IN THE PAST. THIS INFORMATION WAS OBTAINED FROM A PERSON WHO SPOKE WITH RODOLFO MASFERRER ROJAS.

1. ON 4 DEC 64 RODOLFO MASFERRER ROJAS, AKA "KIKI," PAID AN UNEXPECTED VISIT TO THE HOME OF PEDRO VALDIVIA ROMERO AND TOLD HIM THAT HE WAS REPRESENTING HIS BROTHER ROLANDO MASFERRER ROJAS WHO HAD THE FOLLOWING MESSAGE FOR VALDIVIA. PAUL TOUSSAINT DID NOT HAVE A CHANCE TO SUCCEED IN HIS PLAN TO OVERTHROW HAITIAN PRESIDENT FRANCOIS DUVALIER BECAUSE THE UNITED STATES GOVERNMENT CONSIDERED TOUSSAINT TO BE PRO-COMMUNIST. THE ONLY HAITIAN EXILE LEADER WHO HAS A CHANCE TO SUCCEED AGAINST DUVALIER AND WHO ALSO HAS THE APPROVAL OF THE UNITED STATES GOVERNMENT IS FORMER HAITIAN PRESIDENT PAUL MAGLOIRE. RODOLFO TOLD VALDIVIA THAT ROLANDO WANTED

2. RODOLFO ALSO TOLD VALDIVIA THAT VALDIVIA WAS BEING WATCHED BY THE AMERICAN AUTHORITIES BECAUSE OF HIS CONNECTION WITH HAITIAN EXILES. ROLANDO IS TO PROVIDE ADDITIONAL INFORMATION SOMETIME IN THE FUTURE WHEN ROLANDO HOPES TO MEET WITH VALDIVIA.

3. FIELD DISSEM: CINCLANT, CINCSO, COMKWESTFOR, MIAMI REPS OF STATE, FBI, CUSTOMS, I&NS, BORDER PATROL, AND USCG. (ALSO SENT PORT-AU-PRINCE, SANTO DOMINGO.)
