1. Reference is made to your memorandum, dated 29 December 1960, entitled "Urban Intelligence Activities in the United States," in which subject provided information on the Cuban C-2 organization in U.S.

2. Regarding referenced memorandum, the following data, dated January 1961, was provided by a fairly reliable source who has extensive contacts in Cuban emigre circles in the Miami, Florida area:

- The Movimiento Revolucionario del Pueblo (MRP) has established a military training camp on a farm located at Baser Drive, Homestead, Florida, and about four blocks from a farm owned by Hoto V/SQUZ. The following members of the MRP reportedly were receiving training:
