A MEMBER OF A GROUP OF CUBAN EMIGRES TRAINED IN THE TECHNIQUES OF INFORMATION COLLECTION. THE GROUP HAS PROVIDED USEFUL REPORTS SINCE 1961. THIS INFORMATION WAS OBTAINED FROM A PERSON WHO SPOKE WITH DAVID QUINTAS GONZALEZ.

1. ON 6 NOVEMBER 1964, DAVID QUINTAS GONZALEZ, PREVIOUSLY DESCRIBED AS THE MIAMI REPRESENTATIVE OF FORMER CUBAN SENATOR ROLANDO MASFERRER ROJAS, SAID THAT HE HAD BEEN VISITED IN MIAMI BY MASFERRER ON THE NIGHT OF 5 NOVEMBER AND THAT MASFERRER WAS VERY UPSET BECAUSE HE THOUGHT THE HAITIAN EXILES WANTED TO EXCLUDE HIM FROM A COMBINED EFFORT TO INVADE HAITI.

2. QUINTAS SAID THAT HIS (QUINTAS') TRIP TO NEW YORK TO DISCUSS THE SHIPMENT OF ARMS TO MIAMI HAD BEEN CANCELLED BECAUSE MASFERRER CAME TO MIAMI. ACCORDING TO QUINTAS, MASFERRER WANTED TO SHIP THE ARMS FROM NEW YORK TO MIAMI BY SEA.

(FIELD COMMENT: IT WAS PREVIOUSLY REPORTED BY ANOTHER SOURCE WHO IS A TRAINED REPORTER AND WHO HAS BEEN RELIABLE IN THE PAST THAT THE HAITIAN EXILES HAD DECIDED TO EXCLUDE THE PARTICIPATION OF CUBAN EXILES, AND PARTICULARLY MASFERRER, FROM THEIR OPERATIONS DIRECTED AGAINST HAITI. THE SAME SOURCE ALSO REPORTED SUBSEQUENTLY THAT THE HAITIAN EXILES BELIEVED THAT MASFERRER MIGHT CREATE PROBLEMS FOR THEM AS A RESULT OF HIS EXCLUSION.)
