- 1. Ecforonce is node to an inquiry to this Agency from your Bureau conserming Subjects, your Bureau's File No. 100-100086, and this Agency's tolotype No. 19754 dated 26 July 1068, Embject: "VLADIMIR SECEN INTERNAL SECURITY DOMESTICAN REPUBLIC."
- 3. For your background information only, VLADINIA SECEN was From 1963 to 1968 as an occasional course of information on Caribbean matters. SECEN's claim to your Bureau that he was involved in a plan to everthest the Government of Haiti and was being paid by this Agency in furthernies of this plan is completely false. However, SECEN did inform this Agency on two occasions that he was allegedly involved in such a plan. A resume of those reports follows.

 3. On 9 February 1944, CHCEN informed a representative from this Agency in Miscal that he had been effected a post as pilltary advisor to an expedition being formed by Rolando HASFERDER Rojas, former Cuban Semator, to depose President BUVALHER of Haiti. SECEN said he refused the post, but later said that HASFERDER had reserved publicly on several occasions that SECEN had accepted his proposition. According to SECEN, this was a tactic MASFERRER used to enhance the prestige of his novement.
- 4. On 2 March 1966, SECEN told a representative of this Agency in Minmi that he had been contacted on 22 February 1966 by one Mile RAVLIC from Madrid who, according to SECEN, was en route to Maiti to perform a michion for President DUVALIER. According to SECEN, RAVLIC stopped in Minmi to see him. In their meeting, RAVLIC told SECEN that he had been contacted in mid-February in Madrid by a Dominican national residing in Haiti who was allegedly a confident

of Propident DUVALIER. The Deminican told RAVLIC that DUVALIER wanted to see his regarding VLADINIR SECEN. on individual whom DUVALIER ouspected of plotting to overthrow the Government of Halti. DUVALIER wanted RAVLIC to influence SECEN to atop his Haitian plotting and, if SECEN agreed. DUVALIER was villing to offer SECEN a good job in the Haitlan Covernment. SECRA reportedly told RAVLIC that he was not cassed in any plot to overthrow Prosident DUVALIER and did not plan to become involved. RAVLIC then told SECEN that he van going to Haiti to report the regults of his mission to President DUVALIER: hewover, when SECEN varmed RAVLIC that such a trip would be too dangerous, RAVLIC took his advice and returned to Spain.

- 1111- 37700E The files of this Agency reflect that Mile RAVLIC. also brown as uslo RAVLIN do BOGETICH TERCEVICH, Millo 'HRAVIT, and Hajor HILLER, was born 10 June 1919 in Croatia, Yugoslavia and is a naturalized citiesa of the Desinican Republic. He studied agriculture in Zagreb, Yugoslavia, and graduated as an agreematet. During World War II, he was a mamber of the Croatian Army. In 1957, he joined the Desinican Army as a Major and became a Lt. Colonel under Prosident TRUJILLO. In April 1997, a reliable source reported that RAVLIC, who traveled on a Deminican Republic paceport, was apparently involved in an import-export busimoon, but also carried cut political and information-At that thee RAVLIC was reported to mothering micatons. have been in Madrid for the pact month, but had made sevoral trips to France. Squree also said that RAVLEC continged to maintain contact with the MUILLAm. The neet recent information in this Agency's files reflects that in Soptomber 1907, RAVLIC was reportedly in Paris waiting for Mrs. Juan PERON. At that time, RAVLIC told a reliable source that he was in business with Juan PERON.
- 6. Although this Agency has no current operational interest in SECEN, we would appreciate receipt of any information which your Europu may obtain on his activities in the Caribbean area, particularly in the Dominican Republic and Haiti or relating to the Cubana.
- 7. The above information is being made available to your Bureau with the understanding that it will receive no further dissemination without prior approval from this office and will not be used in any interviews which your Eureau might have with SECEN.
