1. AIR FORCE INTELLIGENCE ADVISES THAT MAJ. BERNARD F.

REHKOPF, USAF ASSIGNED TO MACTHAI, HAS BEEN IN TOUCH ASKING ASSISTANCE IN CONTACTING AN LNERGO OFFICIAL. REHKOPF CLAIMS THAT HIS DAUGHTER RITA, WHO FORMERLY WORKED IN BANGKOK FOR LAW FIRM AND IS NOW BASED IN NEW ORLEANS WITH DELTA AIRLINES, HAS TELEPHONED HIM FROM NEW ORLEANS APPROX EIGHT TIMES IN LAST SEVERAL NIGHTS. SHE STATES SHE IS IN THE HANDS OF LNERGO. SHE CLAIMS THAT SHE KNEW JAMES EARL RAY AND SAYS SHE KNOWS HE WENT TO LONDON. SHE FURTHER CLAIMS THAT LNERGO IS PAYING FOR HER PHONE CALLS, AT THE SAME TIME IMPLYING, AT LEAST AS FAR AS REHKOPF IS CONCERNED, THAT SHE IS UNDER A CERTAIN AMOUNT OF DURESS.

3. RECOMMEND HQS ADVISE LNERGO HQS FOR ACTION AS APPROPRIATE. SUGGEST  ALSO PASS GIST OF ABOVE TO LEGAL ATTACHE. THERE IS OF COURSE, POSSIBILITY THAT RITA MERELY HAS AN ACTIVE IMAGINATION. HER REPUTATION WHILE HERE WAS THAT OF FLIGHTY AND IMMATURE PERSONALITY.
