He said that David SALVADOR, disposed-CRG leader, was heading the workers in the "Bloque". AMJUTE-1 also reported that the group of men controlled by ex-Major Raul CHIVAS are also a part of the "Bloque".

6. AMJUTE-1 said that HEVIA told him that all the various military groups are now waiting for acknowledgement from the executive committee of the "Bloque" that they agreed upon representative MONTOYA is acceptable. HEVIA said that the military groups were in possession of some arms and ammunition but lacked supplies for a full scale operation.
