1. AMCLOCK/1 arrived in New York on 19 September 1967. He had been given instructions to call a JMWAVE operational number (Iden A) next time he was out in a friendly country in order to receive contact instructions. When he failed to call soon after his arrival it was decided to try to establish visual contact with him at HTBASTE, same as was done successfully in 1966, to move him to call for contact instructions. For that purpose DI GERVENO was taken to HTBASTE on 21 September carrying a match folder from (Iden B) With his alias, (Iden C, and room number. The plan was to make sure AMCLOCK/1 recognized DI GERVENO, who also met him in 1966, and to pass the match folder to AMODCK/1 only if this could be done securely. DI GERVENO was able to make definite visual contact on four different occasions: once at (Iden D) twice at (Iden E' and a fourth time on the corridor between (Iden D' and (Iden F'. AMCLOCK/1 guickly recognized DI GERVENO and tried to keep himself) available for a possible contact. However this was not possible and the contacts on 21 September were limited to visual recognition only)

2. During this time the operational number of the Beekman site (Iden G) was also manned in case AMCLOCK/1 had retained this number and attempted to call DI GERVENO there instead of JMWAVE, but he failed to call either place for contact instructions. It was then decided to attempt to contact the agent again on 26 September at HTBASTE. While attempts were being made to locate AMCLOCK/1 the case officer surveilled the building where AMCLOCK/1 is staying (Iden H) and saw him go in by himself at 1310 hours to leave his briefcase. At 1330 hours, AMCLOCK/1 left the building alone to go for lunch and DI GERVENO followed him. AMCLOCK/1 recognized the case officer and after exchanging safety signals DI GERVENO passed the match folder to the agent while both were waiting on a crowded street corner for the red light to change, at which time AMCLOCK/1 told DI GERVENO that he had no way to contact him and would see him after lunch.

#### Operational Chrondogy

3. On 26 September AMCLOCK/1 met DI GERVENO from 1500 to 1830 at Iden B. AMCLOCK/1 appeared to be in good health and rested and in high spirits. He was very glad to see LI GERVENO again and to be able to discuss things openly. He criticized bitterly the living conditions in PBRUMEN but does not seem to be affected by it or by the fact that he had to live under a regime he obviously hates. In fact, he seemed quite sure of himself and plans to return to PBRUMEN at the end of the HTBASTE session. He is scheduled to remain in New York until December 1967 but may return to PBRUMEN before then for a short visit to look after his ailing mother and his wife, who had a baby girl two weeks prior to his departure. This may have influenced AMCLOCK/1 not to think about a possible defection at this time, which came as a surprise to the case officer who expected the agent to have second thoughts about return to PBRUMEN where he is not happy.

4. AMCLOCK/1 explained that he could not make contact as instructed because he had destroyed the phone number and both accommodation addresses we had given him for him to report from inside PBRUMEN. He destroyed them in the toilet at the airport upon his arrival in PBRUMEN in late December 1966 after observing a number of uniformed individuals at the airport which he considered to be suspicious, although they had nothing to do with AMCLOCK/1. This may have been a convenient excuse for his failure to make contact as instructed but DI GERVENO did not press the issue. Instead he was given the operational numbers of the Beekman site and of the Base in (Iden I) and told he could always call there if he could not locate DI GERVENO at (Iden B.) He was also given AMCLOCK/1 said he tried to the JMWAVE number for emergency contact. make contact by calling (Iden J) to inquire about MIDDAUGH in true name, but after much probing he was told that MIDDAUGH was in Washington and was given a phone number for him to call direct. AMCLOCK/1 was planning to call Washington at a later day if he had not been contacted.

5. AMCLOCK/1 reported that he has had no security problems and has not been molested inside of PBRUMEN. He was treated "royally" by the AMTHUG regime in early 1967 and everybody seemed pleased to see him back. Apparently his return surprised some individuals who privately thought he would defect rather than return to PBRUMEN to live. During this time he enjoyed special privileges and received frequent invitations to official functions with foreign diplomats. However, by mid 1967 the special privileges and invitations were gradually suspended for no apparent reason. (For example, he was no longer allowed to take his private car to a government garage for repairs and he had to arrange for themaintenance of his house, which was given to him and kept up by the government at first). AMCLOCK/1 believes that this was due to his being under "observation" while going through a reorientation period after his long stay abroad. There is nothing to indicate that AMCLOCK/1 is not trusted or accepted by other government officials. The fact that he was sent out again is anystrong

indication that he enjoys a favorable position in the AMTHUG regime. He hopes that in 1968 he will be assigned to another permanent post abroad.

6. In reference to his wife AMCLOCK/1 stated that he is now convinced that she is totally against the AMTHUG regime. After their marriage in late 1966 he was not sure of her true political ideology but during the past year he has been able to confirm her disagreement on a number of occasions. He feels confident that she would follow him in any movement against the regime, such as defection, but has not told her about his work for WOFACT. Given first first first first

7. (Regarding the trip AMCLOCK/1/reported that with them came Iden R) a known intelligence type, and four other individuals not known to him but believed to be intelligence types. Later AMCLOCK/1 identified these individuals as Idens L, M, N and Q. In answer to specific questions AMCLOCK/1 said that the crate they brought contained only a vase for Iden P. AMCLOCK/1 is not aware if any weapons or special instructions have been sent to Iden P in connection with racial disturbances in WOLADY. The routine instructions given to Iden P were to oppose LNHARP actions in HTBASTE whenever possible and to try to bring all debatable matters to HTBASTE, where they have better support

8. AMCLOCK/1 was not seen going in or out of the room and the meeting was conducted without interruption under most secure conditions. DI GERVENO established immediate rapport with AMCLOCK/1 and their relations remained most cordial throughout the meeting. Only DI GERVENO and AMCLOCK/1 were present.

#### Finances

9. DI GERVENO was careful not to mention salary payments to AMCLOCK/1 who is not aware of his salary increase to \$1,000 a month effective 1 January 1966. However, he requested \$500 to buy books and baby items for his daughter. DI GERVENO told him that he would bring him the money in their next meeting. All payments to AMCLOCK/1 will be T/A'd to JMWAVE together with the agent's signed receipts.

#### Intelligence Production

10. Although most of the meeting was used to discuss operational matters. AMCLOCK/1 reported disseminable information on the following requirements given in DIRECTOR 37960.

a. Present attitude of the PBRUMEN government towards the United States; expectation of a military attack on PBRUMEN supported by the United States; formal military training being given to all PBRUMEN army officials (DO BASE/NEW YORK 3382)

#### Operational Chronology

1. On 27 September 1967 AMCLOCK/1 met DI GERVENO from 1130 to 1530 for lunch at the Beekman site. The agent was not seen entering or leaving the site and he stayed out of sight when food was brought up from the restaurant downstairs. The meeting was conducted under secure conditions and without interruptions. Only AMCLOCK/1 and DI GERVENO were present at the meeting.

AMCLOCK/1 reported that he had been assigned to work in 2. Iden A) with (Iden B) same as last year. A few days before his departure from PBRUMEN, (Iden Citold AMCLOCK/1 to watch out for (Iden B who is a member of the intelligence service and will be reporting on AMCLOCK/1. The implication was that AMCLOCK/1 was still under observation by the AMTHUG regime and (Iden C) actually told him to bend backwards in every way possible to prove himself while in New York. AMCLOCK/l explained that this meant to live a model life while abroad and to perform extra work whenever required, without complaining. AMCLOCK/1 believes that (Iden B is being trained to take over AMCLOCK/1's position as an expert in economics for the AMTHUG regime. If this is the case, this may be the last time AMCLOCK/l is sent to (Iden A) Still, under much probing, AMCLOCK/1 could not come out with any clear indication that he was suspected or was falling out of grace with the AMTHUG regime. Although the agent has a tendency to emphasize his "delicate" position, the case officer believes that he is not mistrusted and still enjoys a favorable position in the government, although probably considered too bourgeois to be completely integrated with their communist philosophy.

3. Regarding the recent changes made in PBRUMEN diplomatic personnel abroad, AMCLOCK/1 was not aware of any security shake up taking place in the Foreign Ministry. He regarded these changes as a routine matter in accordance with their policy to bring back to PBRUMEN for a reorientation tour all those diplomats stationed abroad for three consecutive years or more. AMCLOCK/1 actually

appeared not to be aware of any major purge and not to be concerned about it. However, if this is 'true the chances for AMCLOCK/1 to be reassigned abroad in the near future appear doubtful at this time.

When DI GERVENO asked AMCLOCK/l about his work and how the recent changes may affect him, the agent then reported the following information about his position in the Foreign Ministry. After his return in late December 1966 he was given four months vacation, during which time he went by the ministry from time to time but had no job assigned to him. He used most of this time for a honeymoon and to relocate in his new home furnished by the PBRUMEN government. In the spring of 1967 (Iden C) considered him actively as a substitute for Iden D)whom Iden 9 does not like. However, the job did not materialize because (Iden C's plans to send (Iden D) as Ambassador to Canada were not accepted by (Iden E whom (Iden C was going to send as Ambassador to Switzerland. At that time AMCLOCK/1 was also considered for a position in (Iden F) which was the position the PBRUMEN President wanted him to take, but AMCLOCK/1 avoided the position although it implied frequent Eravels abroad. The reason AMCLOCK/1 gave for not taking the position at (Iden F) was that he did not want to break away from his diplomatic / career and felt he would be better protected among his friends in the Foreign Ministry. Consequently, after his vacation AMCLOCK/1 want back to work in the Foreign Ministry but without any specific duties. He is actually doing odd jobs for (Iden C) like economic studies. In mid 1967 AMCLOCK/1 and [Iden G) were proposed by (Iden C) and accepted by Iden Has members of a four-man committee (the other two members have not been selected yet) which is to be created in the Foreign Ministry to make specific area\_studies and recommendations to (Iden IC Since both AMCLOCK/1 and (Iden G have been assigned to the HTBASTE sension, it is concluded that the creation of said "Advisory Committee" is not contemplated until early 1968. According to AMCLOCK /1 the creation of this "Advisory Committee" has been discussed at the highest levels only and it may have some influence in the policy making decisions of (Iden H) which is the main body that dictates present PBRUMEN foreign policy.

5. It may be well to record here that we should take with a grain of salt the selection of AMCLOCK/1 to such a gensitive source of information as an "Advisory Committee" to Iden Howould be. The agent may be trying to build up his importance to us. It is of interest to note that in the past year that AMCLOCK/1 has been residing inside of PBRUMEN he has made no clear effort to obtain and develop new sources of information and to bring out with him intelligence of particular interest to us. For example, he has no information on the specific requirements we gave him in 1966 prior to his return to PBRUMEN and when asked to identify his main sources of information he said they were his contacts in the Foreign Ministry and Idens I. J. and K. who

are old friends of AMCLOCK/1. (Iden K) is also a cousin of AMCLOCK/1's wife. (AMCLOCK/1 is a difficult individual to debrief on hard intelligence.)

6. Regarding internal security in the PBRUMEN mission in AMCLOCK/1 reported that the entire third floor of the mission is used only by members of the intelligence service. Not even the Ambassador is allowed in that area. Besides Iden B, AMCLOCK/1 correctly identified the known members of the intelligence service permanently assigned to the PBRUMEN mission.

#### Finances

7. AMCLOCK/1 was given \$500 he requested from his escrow account and signed a receipt for this amount, which will be T/A'd to JMWAVE.

8. During the meeting AMCLOCK/1 was debriefed on the following information which was disseminated as indicated:

- a. Changes of PBRUMEN diplomats abroad; expected internal reorganization in the PBRUMEN Foreign Ministry (DO BASE/ 3373)
- b. Advisory Committee on PBRUMEN Foreign Policy (DO BASE/
- c. Informal message sent to PBRUMEN Prime Minister by Mexican President (DO BASE 3375) «
- d. Appointment of PBRUMEN Ambassador to the Congo (Brazzaville) (DO BASE 3374)

#### Future Plan:

9. Next meeting is tentatively scheduled for 29 September between 1300 and 1400 hours. With the assignment of AMCLOCK/1 to (Iden A)his free time will be more restricted from now on for future meetings. However, the agent agreed to contact DI GERVENO, as often as possible.
