5712 PERSIMMON TREE ROAD) BETHESDA, ON HIS WAY TO NEW YORK. WHILE IN WASHINGTON HE WOULD LIKE TO TALK TO SOMEONE RESPONSIBLE IN [REDACTED] CONTINUING EFFECTIVELY HIS FIGHT AGAINST CASTRO.

2. [REDACTED] RECENTLY LEFT CUBA (PERMANENTLY) WHERE HE WAS SUCCESSFUL YOUNG LAWYER. I SUBMITTED COMPLETE BIO DATA ON HIM IN 1960 WHICH SHOULD BE IN INDEY. [REDACTED] IS RESPONSIBLE, INTELLIGENT AND MATURE CUBAN WHO WAS ASSOCIATED WITH A TOP HAVANA LAW FIRM, WHICH NUMBERED AMONG ITS ACCOUNTS MANY US INTERESTS, SUCH AS HILTON HOTELS. HE WAS CAUTIOUSLY ASSOCIATED WITH ANTI-CASTRO UNDERGROUND IN HAVANA, AND WAS A MANOLO PAI FAN.

4. I AM FOLLOWING YOUR LETTER HE WROTE ME. FRANKLY, HE IS BEST SET I WOULD CHECK AS DOING A SMART JOB FOR US OR WHOEVER. IT TOOK HIM LONG TIME TO GET OUT OF CUBA AND NOW HE IS READY TO DO SOMETHING REALLY CONSTRUCTIVE. MAY I HAVE HIM CALL YOU WHEN HE GETS TO YOU, OR WHO WOULD YOU HAVE ME REFER HIM TO?
