1. RESIGNATION (OR FIRING) OF MEXICAN AMBASSADOR

TO INDIA OCTAVIO PAZ HAS RECEIVED PROMINENT FRONT PAGE TREATMENT IN MEXICO CITY PRESS, WITH CHARGES AND COUNTER-CHARGES BETWEEN PAZ AND FOREIGN OFFICE ON WHETHER HE GOT FIRED (OR RESIGNED) AND WHY. FOREIGN OFFICE CLAIMS PAZ MADE STATEMENTS BASED ON INACCURATE PRESS REPORTS WITHOUT ASKING OR WAITING FOR FOREIGN OFFICE CORRESPONDENCE, BUT NO RPT NO REPRODUCTION OF PAZ ALLEGEDLY INAPPROPRIATE STATEMENTS HAS APPEARED IN MEXICAN PRESS. THE REAL REASON FOR PAZ, RESIGNATION (OR FIRING) IS THEREFORE STILL NOT CLEAR.

LEFTIST INTELLECTUALS HAVE PLAYED LEADING ROLE. NOT RPT NOT AT ALL CLEAR WHAT RELATIONSHIP PAZ' REMOVAL FROM NEW DELHI HAS WITH ELENA GARRO'S CHARGES AGAINST LEFTIST INTELLECTUALS (SHE INCLUDED WELL-KNOWN NON-COMMUNIST WRITERS, EDUCATORS AND SCIENTISTS) BUT END RESULT IS THAT ELENA GARRO, THROUGH HER DAUGHTER, IS EXPLOITING OCTAVIO PAZ' REMOVAL TO CONTINUE HER OWN ONE-WOMAN CAMPAIGN AGAINST PROMINENT MEMBERS OF INTELLECTUAL COMMUNITY.
