1. AT NIGHT MEETING 25 JAN 63 [redacted] GAVE CO COPY ORDERS RECEIVED MORNING 25 JAN WHICH READ AS FOLLOWS: COMUNIQUE AGREGADO

[redacted] LIQUIDE SUS ASUNTOS Y REGRESE PARA NUEVO DESTINO. PASAJE SITUADO CUBANA. TERESA PROENZA RECEIVED ORDERS SAME TIME RE RETURN HAVA CONSULTATION. PROENZA BELIEVES [redacted] BEING ASSIGNED IN BUT NO FIRM INFO.

2. MORNING 25 JAN RAMON SINOBAS CALLED [redacted] GAVE HIM CABLE AND TOLD HIM HIS OPINION ORDERS CONFUSED HIS SHOULD HAVE READ CONSULTATION. SAID THAT HE WOULD GIVE HIM AT LEAST TWO WEEKS STRAIGHTEN OUT

AFFAIRS. TERESA PROENZA LATER TOLD [redacted] THAT SINOBAS TOLD HER THAT [redacted] WOULD PROBABLY BE ABLE AVOID REASSIGNMENT THROUGH SISTER IN LAW. [redacted] OPINION SINOBAS CONTINUES PLAY UP TO HIM BECAUSE OF HIS CONNECTIONS HAVA.

MORNING 26 JAN. ON 25 JAN [] SENT FERNANDEZ MEDICINES SHE HAD REQUESTED AND COPY ORDERS PARA 1 VIA MARTA MEDINA CUBANA STEWARDESS WITH INSTRUCTIONS DELIVER ASAP. [] ALSO PLANS TELL TERESA PROENZA WHO SCHEDULED DEPART 28 JAN TELL FERNANDEZ THAT TRANSFER [] WOULD BE UNWISE VIEW THEY WORKING TOGETHER WELL ETC.

4. HQS INTEREST [] RETURN AGAIN BROUGHT UP NIGHT 25 JAN BUT TO NO AVAIL. [] IN ADDITION REASONS CITED REF A SAID OVERRIDING REASON THAT WEALTHY FRIENDS MEXI HAVE INVESTED IN BUSINESS WHICH WILL BE HANDLED BY [] HIS BROTHER, AND CLOSE CUBAN FRIEND ARMANDO PUYOL. MONEY INVESTED VIEW [] FRIENDSHIP AND ASSURANCE HE REMAINING MEXI. [] SAID TO WALK OUT SUCH ARRANGEMENT COMPLETELY UNETHICAL AGAINST HIS PRINCIPLES. IN FACT, SAID HE HAS REMAINED EMBASSY PARTLY BECAUSE HIS DESIRE ASSIST ODYOKE. MEXI SHARES HQS FEELINGS THIS CASE BUT UNFORTUNATELY NOTHING CAN BE DONE. BEST HE HOPED FOR NOV CANCELLATION ORDERS AND HIS CONTINUANCE MEXI.
