1. ON 15 JANUARY 1974, JOE MEROLA RETURNED FROM A BUSINESS TRIP TO SAN SALVADOR, EL SALVADOR. MR. MEROLA THEN CALLED THE MIAMI FIELD OFFICE TO DISCUSS SOME INFORMATION THAT HE HAD COLLECTED WHILE IN EL SALVADOR. HE STATED THAT THE NAME OF THE SUSPECTED CIA AGENT IN THE EMBASSY IN EL SALVADOR WAS NOT A MAN NAMED [redacted] AS PREVIOUSLY STATED, BUT RATHER A MAN

1. ON 19 JANUARY 1974 JOE MEROLA RETURNED FROM A BUSINESS TRIP TO SAN SALVADOR, EL SALVADOR. MR. MEROLA THEN CALLED THE MIAMI FIELD OFFICE TO DISCUSS SOME INFORMATION THAT HE HAD COLLECTED WHILE IN EL SALVADOR. HE STATED THAT THE NAME OF THE SUSPECTED CIA AGENT IN THE EMBASSY IN EL SALVADOR WAS NOT A MAN NAMED [REDACTED] AS PREVIOUSLY STATED, BUT RATHER A MAN NAMED (PHU) [REDACTED]. HE ALSO SAID THAT THE MAN IS NOT THE COMMERCIAL ATTACHE, BUT A POLITICAL OFFICER IN THE EMBASSY. MEROLA HAD PREVIOUSLY SAID THAT THIS INFORMATION WAS PASSED TO HIM BY A EL SALVADORAN SECRET SERVICE AGENT. HE STATED THAT THE NAME OF THE EL SALVADORAN AGENT IS ONE GUILLESIMO (ROEDER). ROEDER APPARENTLY WORKS AS THE PRESIDENT OF AN ORGANIZATION KNOWN AS INSAFI. MEROLA SAID THAT INSAFI IS AN ORGANIZATION

THAT SOMEHOW CONTROLS BUSINESSES THAT WANT TO OPERATE IN EL SALVADOR. HE WAS VAGUE AS TO WHAT THE ACTUAL FUNCTIONS OF INSAFI ARE, BUT HE STATED THAT BY WORKING FOR INSAFI IT

THAT SOMEHOW CONTROLS BUSINESSES THAT WANT TO OPERATE IN EL  
 SALVADOR. HE WAS VAGUE AS TO WHAT THE ACTUAL FUNCTIONS OF  
 INSAFI ARE, BUT HE STATED THAT BY WORKING FOR INSAFI IT  
 ALLOWS ROEDER TO HAVE ACCESS TO MANY FOREIGNERS WHO WISH TO  
 DO BUSINESS IN EL SALVADOR. MEROLA SAID THAT THE WIFE OF  
 ROEDER WORKS IN THE U.S. EMBASSY AS A SECRETARY AND IS CURRENTLY  
 ON MATERNITY LEAVE. END OF REPORT
