1. LIENVOY REPORTED 14 JANUARY THAT AT 10:50 HOURS A LONG DISTANCE TELEPHONE CALL WAS RECEIVED AT THE CUBAN CONSULATE TEL 511-25-47 MEXICO CITY. ED GRADY PARTIN WHO SAID CALLING FROM ATLANTA GEORGIA ASKED FOR CONSUL RAFAEL MIRABAL FERNANDEZ. PARTIN SPOKE NO-SPANISH, SPOKE ENGLISH WITH STRONG SOUTHERN ACCENT. ASKED WHETHER MIRABAL REMEMBERED HIS (PARTIN'S) WIFE, MOTHER AND SMALL DAUGHTER HAD GONE TO SEE MIRABAL IN MEXICO 6 OR 3 MONTHS AGO ABOUT A MATTER AND PARTIN WANTED TO KNOW IF MIRABAL HAD ANY NEWS. MIRABAL CHECKED AND SAID NO. (PRESUMABLY CONCERNS CUBAN VISA.) MIRABAL SAID HE COULD NOT MAKE DECISION IN MEXICO AND HAD NO IDEA HOW LONG MATTER WOULD TAKE. MIRABAL HAS PARTIN'S ADDRESS AND WILL WRITE HIM WHEN HE HEARS. PARTIN INSISTENT. HE SAID "TIME IS GETTING SHORT" AND INSISTED ON CALLING MIRABAL LATER. THEY AGREED PARTIN WOULD CALL IN TWO WEEKS. BELIEVE PARTIN WILL CALL PRECISELY IN TWO WEEKS WHICH WOULD BE JAN 28. STATION WILL BE ALERT FOR ANOTHER LONG DISTANCE CALL. SAVING ORIGINAL REEL FOR VOICE COMPARISON.
