A sensitive source has reported that a representative of the provisional Government of South Vietnam stationed in Stockholm, Sweden requested that the March 5th Black Panther Party Solidarity Committee meeting held in Uppsala, Sweden be taped and sent to him. The unidentified representative stated that he wanted to use the tape for radio replay to American soldiers based in South Vietnam.

2. The above is being provided in response to your request transmitted in your memorandum dated 29 March 1971, Subject: WPAX, Incorporated Sedition (IS).
