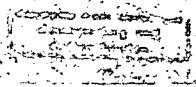
I. LATE DEVELOPMENTS AMCANOE OP.

A. 4 DEC. OSCAR FERNANDEZ AND FREDDY GARCIA CALLED MANGANELLO TO CLARIFY ADDITION, UNCLEAR, PORTIONS 3 DEC CALL BETWEEN AMCANOE-3 AND FREDDY GARCIA. IN A-3/GARCIA CONVERSATION, A-3 STATED "MAKE CERTAIN YOU TELL MY WIFE THAT EMELINA ME ABRAZO REPEAT EMELINA ME ABRAZO." A-3 WIFE IN MIAMI ADVISED THIS PRIVATE CODE PHRASE BETWEEN HUSBAND AND WIFE MEANING A-3 IN IMMINENT DANGER, THAT HE ARRESTED OR ABOUT TO BE. ACCORDING TO GARCIA, IT OBVIOUS THAT A-3 COULD NO LONGER USE CASE OFFICER CHALLENGE I.E. HAIR DYING, TWO LEFT FEET, SINCE AMCANOS-7 ALSO GIVEN SAME CHALLENGE AND IT PROB KNOWN NOW TO USE.

B. GERARDO COWLEY IS BROTHER-IN-LAW OF JOSE "PEPINO" MARTI, PARI-MUTUAL EMPLOYEE WHOSE ARREST REPORTED REF. MARTI ALSO KNEW A-3 SAFEHOUSED AT EMILIO FLIGA CABANAS. BOTH MARTI AND COWLEY FRIENDS A-3 COWLEY AND CARBO FRIENDS ALSO.

C. EVENING 3 DEC. SON OF FLORA "VENON" SOTOLONGO ADVISED MARTI IN LETTER 2 OCT, MOTHER STATED AMCANOE-3 WAS AGAIN

WAS HOUSED THERE AND FINE. IN LETTER DATED 8 OCT, MOTHER STATED AMCANOE-3 NO LONGER THERE BUT FINE. FINAL LETTER DATED 15 NOV MOTHER STATED AMCANOE-3 STILL FINE. SON RECEIVED CALL 3 DEC FROM INSIDE STATING THAT HIS MOTHER HAD LEFT FOR "SHOPPING" ON 23 NOV AND NOT BACK YET. TO SON AND GARCIA THIS COVER CONVERSATION MEANS MOTHER ARRESTED BY DSE. FLORA IS AUNT AMCANOE-3 WHO SAFE-HOUSED A-3 DURING HIS PREVIOUS CLANDESTINE TRIPS CUBA AND HAS TELEPHONE NR 210-773.

D. OSCAR FERNANDEZ HAD SON OF FLORA TELEPHONE HABANA 4 DEC. SON REPORTED IT CONFIRMED THAT MOTHER AND FATHER HAD BEEN ARRESTED SINCE 23 NOV.

2. NO WAVE TRACES FLORA SOTOLONGO, HOWEVER 62 HABANA TELEPHONE DIRECTORY LISTS SUBSCRIBER OF NR 210-773 AS FELIPE GOMEZ ALBARRAN (271-739526) CALLE 182 NR 1312. SUBJ IS ARCHITECT AND OFFICER MINISTRY OF INDUSTRIES FORMERLY IN CONTACT GEORGE R. SINIARIS HAVA STATION CASE OFFICER AND AGENT CANDIDATE AMGLEN-9, GRANTED POA PER DIR 84390. AMGLEN-9 IN CONTACT THROUGH EMILIO CARBO. OSCAR FERNANDEZ REPORTED FLORA SOTOLONGO MENDEZ IS FELIPE GOMEZ WIFE.

3. GARCIA ALSO REPORTED CHANGE IN INFO PARA 1 C REF. PHONE NUMBER WAS NOT OBTAINED FROM AMCANOE-3 BUT FROM HABANA OFFICE.

4. WAVE NOT PLANNING USE STATION ASSETS EXFIL AMCANOE-3 OR OTHER AMCANOE CONTACTS UNTIL RECEIVE FULL CLARIFICATION HIGHLY SUSPICIOUS DEVELOPMENTS SURROUNDING AMCANOE-3 PAST THREE WEEKS WHICH INCLUDE:

a. ARRESTS OF JOSE MARTI, FELIPE GOMEZ ALBARRAN AND WIFE, BOTH OF WHOM HAD DIRECT CONTACT WITH A-3.

b. ENRIQUE FERNANDEZ WHO EITHER ARRESTED, DOUBLED OR IN

5. HAVE PLANNING TRY CAUTERIZE PROBABLE OPS DAMAGE BY
