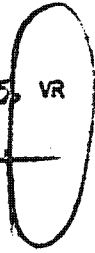

1. LAJULIA PASSENGERS APPARENTLY FOLLOWING RECENT REFUGEE PATTERN AND HEADING FOR U.S. BORDER WITHOUT WAITING FOR VISAS MEXI. ANSUPER-1 CONTACTED SEVERAL AND DEVELOPED FRAGMENTARY INFO.

2. FOLLOWING FROM [REDACTED]

[REDACTED] LOBSTER FISHING BOAT FROM ISLE OF PINES: BOAT BELONGS TO "MARTIRES DE BAIRE" FISHING COOPERATIVE, REGISTRY NUMBER C-14-C10, FORMERLY BELONGED TO EX-COLONEL CARLOS PONCE OWNER OF COMPANIA DE PRODUCTOS DE ISLA DE PINOS, [REDACTED] SAID THAT IT WAS DECIDED THAT "CONRADO" WHOSE MATRONYM IS [REDACTED] WOULD ADVISE [REDACTED] THAT CLANDESTINE EQUIPMENT AND MATERIAL RECEPTION OPERATION SCHEDULED FOR 2300 HOURS TO 0100 HOURS, 22 - 23 OCTOBER, 1800 DEGREES SOUTH OF CAJOS DE ACUARDIENTES, COULD NOT BE HELD DUE TO ILLNESS [REDACTED] AND BECAUSE [REDACTED] COULD NOT BE AUTHORIZED TO MAKE SICK UP IN VIEW OF FACT HE UNDER SUSPICION AND RECENTLY PRISONER. "CONRAD" WAS ADVISED OF THIS ON 20 OCT. SO HE COULD TELL [REDACTED] THAT BOAT COULD NOT BE SENT OUT FOR

3. [] ARE BOTH WILLING TO UNDERTAKE FURTHER MISSIONS IN THIS AREA WHICH THEY KNOW WELL. THEY THINK THAT [] OWNER OF BOAT [] REGISTRY [] WILL HELP, ALSO POSSIELY [] SHRIMPER, OWNER OF BOAT [] REGISTRY [] ALTHOUGH [] SOMEWHAT LACKING IN COURAGE.

4. [] SAYS CAYOS AGUARDIENTES IS GOOD SPOT SINCE NO REEFS FOR TEN MILE STRETCH AND UNINTERRUPTED LINE OF NAVIGATION FROM [] TO OPEN SEA.

5. [] WILL BE AVAILABLE SOON AT ADDRESS OF [] [] WEST PALM BEACH, PHONE []

6. FOLLOWING FROM [] WHO UNCLE OF [] WAS LEADER OF MONA RESISTANCE MOVEMENT (MOVIMIENTO ORGANIZADO LOCAL ANTICOMUNISTA), RECEIVED INSTRUCTIONS FROM [] EX-AVIATION COMANDANTE WITH INDENTED SCAR ON FOREHEAD, AND FROM [] MONA OPERATED ON SIGNAL "TAMAKUN." CODE NUMBER ONE MEANT "LISTAS LAS ARMAS PARA RECIBIR" AND CODE NUMBER TWO MEANT "PREPARADOS PARA SALIR." IN APRIL 1962 MONA RECEIVED MSG "TAMAKUN ONE TWO" BUT NO CONFIRMATION OF DATE AND HOUR OF MISSION. TWO WAY CONTACT LOST AFTER THAT. AT ONE TIME GROUP RECEIVED MSG "LLAMANDO A TAMAKUN, ENTREVISTA A BENJAMIN" BUT THEY HAD NO CONTACTS OR CODES MENTIONING BENJAMIN AND COULD NOT ACT ON THIS.

7. [] WAS WITH HIM A MSG IN A NEW CODE WHICH HE IS TO DELIVER TO CHIEFS OF HIS MOVEMENT.

8. MONA MEMBER BENITO ORTEGA WAS ARRESTED IN OSTOER AND EXECUTED IN LA CAERANA FORTRESS. MEMBERS IN PRISON AND SENTENCE ARE "LIMPIO" RIVES, 30 YEARS; "MACHO" ORTIZ, 30 YEARS; RICARDO BLANCO, 20 YEARS AND RIGOBERTO "GUAO" PALENZUELA LOPEZ, 20 YEARS. "GUAO" WAS IN CHARGE OF MONA IN HAVANA, CONTACT WITH HAVANA BROKEN SINCE HIS ARREST JUNE 1963. NONE OF PERSONS EXECUTED OR IN PRISON KNEW OF TAMAKUN OPS.

9. [] 1962 MISSION WAS SOUTH OF CAYO CAMPOS. HE SAYS VIGILANCE IN THIS ZONE MERELY ROUTINE WITH PERIODIC SEARCHES OF SHORE LINE TO CATCH PERSONS TRYING ESCAPE. FEELS THAT FISHERMEN AND LOESTERMAN IN ZONE ARE ALL ANTI-REGIME WITH ONLY SMALL NUMBER OF PRO-REGIME PEOPLE AMONG 400 PLUS FISHERMEN ISLE OF PINES.

10. [] REPORTS HE UNAWARE OF ANY CLANDESTINE ACTIVITY OTHER THAN THAT IN WHICH HE INVOLVED IN INTERIOR OF ISLAND WHERE HE WORKED IN REPAIR SHOP. [] WAS IMPRISONED SEVERAL TIMES, WORKED CLANDESTINELY WITH [] AND [] BOTH NOW IN U. S.

11. NO ONE CONTACTED KNOWN []

12. STATION HOPES ABOVE JUMBLE OF INFO WILL PROVE USEFUL WAVE. SUGGEST BEST METHOD PICK UP GROUP AS FILTERS ACROSS BORDER IS THROUGH ADDRESS PARA 9.
