LUIS TORRES ORDOÑEZ, PRESIDENT FOR 1963 AND 1964 OF THE SOCIEDAD MEXICANA DE AMISTAD CON CHINA POPULAR (SMACP - MEXICAN SOCIETY OF FRIENDSHIP WITH PEOPLE'S CHINA), CULTURAL COMMUNIST FRONT ORGANIZATION IN MEXICO, SAID THAT THE CHINESE COMMUNIST INDUSTRIAL TRADE FAIR WHICH IS TO BE HELD IN MEXICO CITY WILL OPEN ON 3 DECEMBER 1963 AND IS SCHEDULED TO CLOSE ON OR ABOUT 17 DECEMBER 1963.
