1. SUBJ FINALLY LOCATED AT CLINICA MERCEDES CORIA, MEXI. WAS APPROACHED ALONE ON BEHALF AMBUD MEXI NIGHT 21 NOV BY FRIEND [ ] WHO PASSED ON STORY OF PARA ONE REF WHICH [ ] BELIEVES TRUE. SUBJ VERY DEJECTED, "DIFFERENT MAN" FROM USUAL EBLLIENT SELF. [ ] MADE PITCH, SAID HE ONCE WAS MIXED UP WITH COMMIES AT UNAM BUT SAW LIGHT AND FEELS NOT TO LATE FOR SUBJ FACE FACTS AND MADE BREAK.
