WOULD BE WITH INTERNATIONAL TRANSPORTWORKERS FEDERATION (ITF), HEAD-  
QUARTERED LONDON, TO WHICH BELONG U.S. RAIL UNIONS, INCLUDING INFLU-  
ENTIAL BROTHERHOOD OF RR CLERKS (BRC).

2. PHILIP P. FEINRIDER (F) LONG TIME KUBARK d8 (BACK-  
GROUND INFO THIS <sup>02</sup> AVAILABLE IN MATERIAL POUNCHED GUAT FROM PACY FOLLO-  
ING <sup>02</sup> [S]SALAD CONFERENCE) WILL ATTEND PAN AMERICAN RAILWAY CONGRESS  
MEXICO CITY 15-31 OCT AS IDEM. CONGRESS IS PERIODIC MEETING OF MANAGE-  
MENT LABOR GOVT DELEGATIONS FROM 16 COUNTRIES TO DISCUSS COMMON PROBLEMS  
IN RAILROADING. VERY TIGHT SCHEDULE WILL PROBABLY PRECLUDE SIDE TRIP  
BY F TO GUATEMALA. HOWEVER IF GUAT IS ABLE ENSURE RIGHT KIND OF SAMP  
DELEGATION TO CONGRESS, F DISCUSSIONS WITH DELEGATION IN MEXI SHOULD  
LAY GOOD BASIS FOR <sup>REF</sup> EFFORT. IF GUAT FEELS IT DESIRABLE TO ENSURE  
DIRECT ON EPOT GUIDANCE FOR FOLLOW-UP ACTION THROUGH F AND ITF, GUAT  
C/O MAY WISH COME MEXI FOR DIRECT CONTACT WITH F DURING CONGRESS.
