1. KUBARK OPERATIONS SUPPORTING GENERAL ODYOKE ECONOMIC DENIAL PROGRAM AGAINST CUBA ARE BECOMING SO PERVASIVE AND COMPLEX IT NOW NECESSARY SET UP PROGRAM IN ORDER CHANNEL CORRESPONDENCE ALL INTERESTED COMPONENTS, CATEGORIZE ASSETS, ENSURE EFFICIENT COORDINATED HQS ACTION, MAINTAIN SATISFACTORY RECORD OF ACCOMPLISHMENTS, ETC. IDEN A IS TRAFFIC SLUG ASSIGNED THIS PROGRAM.

2. AS IN ALL CUBAN OPERATIONS, TRAFFIC ON CUBAN ECONOMIC WARFARE AND DENIAL OPERATIONS WILL BE ELICITED IN ACCORDANCE WITH PARA 2 OF COMF NO. 70-2 DATED 31 JANUARY 1963, WHICH IN EFFECT GIVES THE ACTION RESPONSIBILITY TO THE APPROPRIATE AREA DIVISION AND INFO TO SAS. IN ADDITION, ORIGINATORS OF CORRESPONDENCE WILL USE THE IDEN A SLUG PLUS THE CRYPTONYM OF ANY ECONOMIC WARFARE AGENT OR OPERATION BEING DISCUSSED. IDEN A SLUG SHOULD BE USED ON ALL TRAFFIC CONCERNED WITH CUBAN MACHINATIONS INVOLVED BUYING, SELLING, AND SHIPMENT OF PARTS AND SUPPLIES, E. G. LUNAR ATTEMPTS DISPLACE EASTERN AND STANTLANDER, SYREL/UNSIGMA WHEN THEY INVOLVED ETC. DO NOT CONFUSE WITH

IDEN B WHICH SEPARATE PROGRAM CONCERNED WITH RECRUITMENT CUBAN SEAMEN AND SABOTAGING OF CUBAN SHIPS AND CARGOES. HQS AND FIELD COMPONENTS ORIGINATING CORRESPONDENCE ON ANY ASPECT OF THE IDEN A PROGRAM WILL MARK FOR FILING IN 201 DOSSIER OR DIVISION PROJECT FILES SIMILAR TO ANY OTHER OPS MATERIAL. IDEN A FILE, A CS SUBJECT FILE, HAS BEEN ASSIGNED NO. 200-120-58, RESTRICTED TO CORRESPONDENCE OF A GENERAL NATURE OF CONCERN TO ALL ADDRESSES.

3. INTRL REPORTING ON THIS SUBJECT SHOULD ALSO BE SLOGGED IDEN A. PROSPECTS ATTAINING ALMOST COMPLETE COVERAGE CUBAN PURCHASING, BARTERING AND OTHER COMMERCIAL ARRANGEMENTS VIA PENETRATIONS AND AUDIO APPEAR EXCELLENT. CUSTOMER INTEREST THIS MATERIAL AS INTEL COINCIDES WITH OPS INTEREST IN DENIAL. ALL RAW REPORTING SHOULD BE SCREENED AT STATION FOR INTEL RESPONSIVE TO ECON REQUIREMENTS. CABLE SIGNIFICANT ITEMS AND GIVE LOCAL DISSEM WITHIN LIMITS SENSITIVITY. BALANCE MATERIAL COVERING LESS IMPORTANT ITEMS TO BE POUCHED HQS IN RAW FORM OR TURNED OVER TO KDO AS APPROPRIATE. GENERAL ACTION LOGICALLY SHOULD FOLLOW ON BASIS DISSEMINATED INTL. SENSATIONS SHOULD COMMENT ON POSSIBILITIES OR RECOMMEND ACTION BY SUPPLYING OUR CASES. HQS WILL THEN CONSIDER MERITS OF CASE AND DAREBALL OFFER OF PRIVATE SUPPORT FOR OPERATION AS FEASIBLE.

A. THE FOLLOWING ARE PRINCIPAL ECONOMIC DENIAL TARGETS IN STRATEGIC ORDER:

A. ELECTRIC POWER GENERATING PLANTS WITH EMPHASIS ON REPLACEMENT VITAL PARTS.

B. PETROLEUM REFINERIES AND INDUSTRY WITH EMPHASIS ON CRUCIAL VITAL PARTS AND DENIAL BRIGIT STOCK AND LUBE OIL ADDITIVES.

C. TRANSPORTATION, WITH EMPHASIS ON DENIAL OF REPLACEMENT PARTS FOR SHIPS, DIESEL LOCOMOTIVES, TRACTORS, TRUCKS, BUSES, AND AUTOMOBILES.

D. MISCELLANEOUS ITEMS WITH EMPHASIS ON PARTS FOR MACHINERY USED IN KEY INDUSTRIES.

3. HQS WILL AWARE STATION WORKLOAD FACTORS AND IMMINENT TENDENCIES THESE PROGRAMS PERIODICALLY OVERWHELM FACILITIES AND OTHER CURRENT BUSINESS.
