1. ⁰⁴[KUBRYNER] OF OPERATIONAL INTEREST DURING TOUR ¹⁰[] 57 TO 61 AND IN SOCIAL CONTACT KUBARK OFFICER. BELIEVED RECRUITABLE VIEW FAVORABLE ASSESSMENT FROM FORMER ASSOCIATES, PURGE JEWISH OFFICIALS. SEE WESTERN EMULATION AND DEVOUT CATHOLIC WIFE. LETTER SENT SUBJ BY ⁰²[HE] VOCAL WHO FORMERLY IN OFFICIAL AND SOCIAL CONTACT. SUBJ ANSWERED BUT DID NOT APPEAR DISAPPOINTED HIS SITUATION. NO PITCH MADE ALTHOUGH HE STILL CONSIDERED RECRUITMENT TARGET IF STATIONED WEST AGAIN.

OLD UNCONFIRMED REPORTS INDICATED SUBJ INVOLVED ECONOMIC ESPIONAGE FOR US DURING TOURS ¹¹[] 46 TO 50. ⁰¹[REVISION] REPORTED SUBJ UNDER INVESTIGATION US DEPARTMENT XI (CE) IN 60 DUE HIS MANY WESTERN CONTACTS. SUBJ CURRENTLY IN CONTACT REFUGEE OFFICIALS WARSAW AND HQS HAS REASON BELIEVE HE REPORTING FULLY TO US.

3. VIEW SUBJ LIMITED STAY MEXICO AND QUESTION RE CURRENT US STATUS DO NOT FILE ATTACHE. IF ANY GROUND ASSETS ABLE ESTABLISH CONTACT AND
