2. HAVE ADVISED [ ] THAT BECAUSE OF LIMITED TIME UNABLE ARRANGE HIS TRANSPORTATION AND INSURE THAT HE WOULD ARRIVE IN TIME SEE SUBJECT. HE UNDERSTANDS AND PLANS CALL SUBJECT AGAIN PRIOR 16 OCT TO EXPLAIN COULD NOT MAKE ARRANGEMENTS FOR TRIP ON SUCH SHORT NOTICE.
