1. SOVIET BLOC HAS MOVED STRONGLY INTO MEDIA FIELD IN EAST AFRICA BY OBTAINING AGREEMENTS TO PROVIDE SOVIET AND CZECH NEWS SERVICES. TELETYPE UNIT, PRESS TECHNICIANS AND JOURNALIST TRAINING FOR NEWLY CREATED KENYA AND TANGANYIKA NEWS AGENCIES. PATTERN OF STATE CONTROL OVER NEWS ACQUISITION AND DISTRIBUTION IS CLEARLY EMERGING THESE TWO COUNTRIES, WHERE LEFTISTS IN GOOD POSITION TO PROVIDE PRO SOVIET BLOC, ANTI-ODYOKE SLANT TO CONTROLLED NEWS. REPORTS INDICATE NEWSPAPERS WILL BE OBLIGED TO PURCHASE AND PRINT NEWS FROM THESE BLOC SUPPORTED AGENCIES. NO MOVE YET TO EXCLUDE WESTERN NEWS SERVICES BUT THEY WILL FIND IT DIFFICULT TO COMPETE WITH SUBSIDIZED GOVT-RUN NEWS AGENCIES BACKED BY POLITICAL PRESSURE. SOME INDICATION OF BLOC INTEREST IN UGANDA MEDIA ALSO.
