1. INDICATED BOTTLE FOR INFORMATION THAT SOVIET IS CURRENTLY FACING ECONOMIC DIFFICULTIES. AS BOILED DOWN, ITEMS INCLUDED AS OPERATIONAL AID FOR ASSESSMENT AND EVALUATION OF SOVIET, AND AS MEANS HOW DOUBT RE REGIMES ABILITY DEAL WITH INTERNAL PROBLEMS. RECEIPIENTS SHOULD NOT MENTION ANY THING BUT THESE ARE APPROPRIATE FOR OWN USE. REPORT DIRECTLY CONTACTS VIA OWN CHANNELS. SOS WILL SCOUR FOR VALID TEL.

2. WESTERN PRESS (REUTERS VIENNA 16 NOV) REPORTED RIOTS BY WORKERS KIROV ROO. RIOTSORS WERE BREAD SHORTAGE AND DEMAND FOR WAGE INCREASES AFTER RAISING FOOD COSTS. SINCE NO ANNOUNCEMENTS FOOD PRICE INCREASES TO DATE, ARE THEY BEING RAISED SECRETLY? WHAT ITEMS AFFECTION? BREAD PRICES HOW INCREASED? HOW MUCH? AS MUCH AS THIRTY PERCENT PPER MEAT PRICES LAST YEAR? HIGHLIGHTS WHEN MEAT AND MILK PRICES INCREASED

3. KERCHENKOV IN PISROW SPUNCHED SAID GRAIN CROP TINYLY PLEASANT BELOW LAST TIME BUT MEAT QUALITY UP. IN LATTERM MENTION EXTENSIVE BUSINESS SLAUGHTERED LIVESTOCK IN VARIOUS SEVERE FORMS AND SOONER KERCHENKOV ALSO SAID MILK PRODUCTION DOWN THIS TIME. DOES THIS INDICATE THAT MILK COMES WITH SLAUGHTERED DAIRY POULTRY?

4. IF PIGS IN SUCH SHORT SUPPLY WOULD BE SUBSTITUTED FOR HAM, WILL BOVINE CONSUMPTION FOLLOW HAMMY EXAMPLE AND BUY FEED GRAINS APPROAD, IN ADDITION WHILST FOR HUMAN CONSUMPTION?

- Q. IF USSR RELIEVES LONG TERM CREDIT FROM WEST FOR CHEMICAL PROGRAM AND SPACER, WHAT MEASURES HE TAKES PAY BACK LOAN? WILL INVESTIGATE IN SOONER, IS IT POSSIBLE OTHER SOLUTION AT HAND?
- Q. PRIVATE PLOTS OF PARM WORKERS MOST INPRODUCTIVE DUE SOVIET AGRICULTURE,
 TO ADDITIONAL INVESTMENT WHICH WOULD REMOVE LABORING GATE FOOD SUPPLY. THIS
 COULD BE USED AS SOIL FERTILIZER OR SOIL PEASANTS FOR USE ON PLOTS?
