2. IMMEDIATE NEED INFO HEADQUARTERS AND WAVE WHETHER ALL TOURIST CARDS OF PASSENGERS ARRIVING MEXI AIRPORT HAVE SUCH NEW CACHET AND EFFECTIVE DATE.
