1. ALTHOUGH TAKE MUCH NOISE OF TAPES WHERE PUMP OFF, GENERAL AUDIBILITY OF TARGET CONVERSATIONS POOR BUT WE BELIEVE TO TWO REASONS:

A. RECORDING LEVEL APPARENTLY EXTREMELY HIGH THEREBY SERIOUSLY COMPOUNDING DISTORTION PROBLEMS ALREADY PRESENT IN HARD ROOM. SUGGEST RECORDING LEVEL BE TURNED DOWN.

B. MIKES PERIODICALLY APPEAR TO CUT OUT. IF AUTOMATIC GAIN CONTROL (AGC) BEING USED, THIS PROBLEM PROBABLY CONNECTED TO VOLUME PROBLEM IN THAT AS NOISE THRESHOLD INCREASES AGC IS CUTTING OUT MIKES. FOR EXAMPLE FOOTSTEPS CROSSING ROOM TOWARD MIKES APPEAR TO BE ONE CAUSE THIS CUT OUT. IF THIS IS PROBLEM, DECREASING RECORDING LEVEL MAY REMEDY.

2. TAPES WHERE PUMP ON ALL ENAUNDIRS HOWEVER IN LIGHT SPORADIC OPERATION OF PUMP. DEFER MEXI RE NEED TAKE STEPS DED 47991.
