1. SUBJ REFS CONTACTED <sup>20-4</sup> [ ] VIA <sup>02</sup> [UN]SNAFU/9 ON 25 MAY, TO REQUEST AID, SUBSEQUENTLY REFUSED ON SECURITY GROUNDS, IN OBTAINING SPANISH VISA AS REPORTED REF B. IN ADDITION TO REF B, FOLLOWING POINTS DISCUSSED WITH MIRRLEES WHO HAD TWO MEETS WITH SUBJ ON 25 MAY, FIRST AT MEET WITH <sup>02</sup> [UN]SNAFU/9 AND SECOND BAR HOTEL NAPOLEON TO GIVE SUBJ ANSWER ON VISA.

2. SUBJ STATED HAD BEEN IN CONTACT WITH KUBARK 15 TIMES AND 15 TIMES HAD DISSOLVED RELATIONSHIP. STATED KUBARK LAST ATTEMPTED CONTACT HIM NEW YORK VIA ODURGE TWO MONTHS AGO AND THAT HE THEN AGREED TO CONTACT. SUBJ STATED NOT INTERESTED IN CONTACTS WITH LOW-LEVEL TYPES, ONLY HIGHEST PBPRIME LEVELS. SUBJ STATED HAD MANY HIGH LEVEL FRIENDS IN PBPRIME GOVT. NAMED BOBBY KENNEDY AS ONE WHO ONCE HELPED HIM OUT OF JAM. SUBJ SAID TOOK PART MANY RAIDS

3. SUBJ SPOKE IN SAME VEIN OF DISCONTENTMENT OF "NO ACTION" AND OF MADR GROUP, SPECIFICALLY NAMING <sup>02</sup>[UN]SPORT/1, AS DID AMLASH/3, <sup>02</sup>[UN]SNAFU/9. AS REPORTED REF B, SUBJ STATED WOULD HAVE <sup>02</sup>[UN]SPORT/1 KICKED OUT (PRESUMABLY KUBARK) AS SOON AS POSSIBLE. SUBJ AND <sup>02</sup>[UN]SNAFU/9, AS WELL AS AMLASH/3, HAVE REPEATED EXPRESSED THEIR HIGH REGARD OF BELIEF IN AMLASH/1. NOW THAT AMLASH/3 IS IN PBRUMEN, SUBJ AND <sup>02</sup>[UN]SNAFU/9 SPEAK OF HIM IN SAME RESPECT AS AMLASH/1. SAID THEY ARE NOW RISKING LIVES AND ONLY WAY THEY WILL GET OUT OF PBRUMEN WILL BE STEAL <sup>LA</sup>P~~RI~~ME AND ATTEMPT ESCAPE. <sup>02</sup>[UN]SNAFU/9 HAS STATED SEVERAL TIMES, SINCE APRIL BOTH TO GLOADEN AND MIRRLEES, THAT "SOMETHING BIG" GOING TO <sup>A</sup>HAPPEN IN NEXT THREE MONTHS. SUBJ AND <sup>02</sup>[UN]SNAFU/9 BOTH STATED TIME IS RIPE FOR ACTION.

4. SUBJ ARRIVED IN <sup>IS-4</sup>[ ] FROM LOND ON 21 MAY. WHEN MIRRLEES ASKED SUBJ WHY HIS KUBARK CONTACTS IN PBPRIME HAD NOT PROVIDED NECESSARY ARRANGMENTS FOR VISA, SUBJ STATED HIS BUSINESS MADR NOT KUBARK SPONSORED AND KUBARK NOT AWARE OF IT. SUBJ INSISTED IT IMPERATIVE HE ARRIVE MADR 25 MAY TO SPEAK TO "IMPORTANT MEMBER THEIR GROUP." SUBJ SAID ALSO SHOULD HAVE BEEN IN ZRMETAL BY 25

CHECK WITH HER BOSS BUT CERTAIN WOULD BE DENIED ON SECURITY GROUNDS)  
TWO FRIEND<sup>S</sup> OF SUBJ APPEARED: MAN NAMED "FRANK" APPROX 26-29  
STATED HAD KNOWN SUBJ LONG TIME. GIRL "DANIELLE" APPROX 20 DID  
NOT SPEAK. BOTH APPEARED BE STUDENTS. MAN APPEARED EFFEMINATE.  
SUBJ PROPOSED MIRRLEES JOIN GROUP FOR DINNER BUT MIRRLEES DECLINED  
OFFER AS HAD OTHER PLANS.

6. FROM ABOVE, IT OBVIOUS THERE TWO DIFFERENT STORIES RE KUBARK  
CONTACT WITH SUBJ. SUBJ'S LINE OF THOUGHT EXACTLY, ALMOST TO SAME  
WORDS, AS THAT OF AMLASH/3, <sup>02</sup> [UMSNAFU/9].

7. REGARDING PARA TWO REF A, STATION NOT AWARE COMMENT THIS SUBJECT  
IN GROUPS NOT ALREADY CONNECTED WITH AMLASH ONE. FROM HERE PROB-  
LEM SEEMS BE THAT AMLASH CIRCLE IS WIDE AND EACH NEW FRIEND OF WHOM  
WE LEARN SEEMS TO HAVE KNOWLEDGE OF PLAN.
