WHEN MIRRLEES ASKED SUBJ WHY HIS KUBARK CONTACTS IN PEPRIME HAD NOT PROVIDED NECESSARY ARRANGMENTS FOR VISA, SUBJ STATED HIS BUSINESS MADR NOT KUBARK SPONSORED AND KUBARK NOT AWARE OF IT. SUBJ INSISTED IT IMPERATIVE HE ARRIVE MADR 25 MAY TO SPEAK TO "IMPORTANT MEMBER THEIR GROUP." SUBJ SAID ALSO SHOULD HAVE BEEN IN ZRMETAL BY 25

WHEN MIRRLEES HAD SECOND MEET WITH SUBJ TO CONFIRM RESULTS OF TAL OF WITH STOCKWOOD RE VISA (MIRRLEES FIRST TO SUBJ SHE WOULD CHECK WITH HER BOSS BUT CERTAIN WOULD BE DENIED ON SECURITY GROUNDS) TWO FRIEND OF SUBJ APPEARED: MAN NAMED "FRANK" APPROX 26-29 STATED HAD KNOWN SUBJ LONG TIME. GIRL "DANIELLE" APPROX 20 DID NOT SPEAK. BOTH APPEARED BE STUDENTS. MAN APPEARED EFFEMINATE. SUBJ PROPOSED MIRRLEES JOIN GROUP FOR DINNER BUT MIRRLEES DECLINED OFFER AS HAD OTHER PLANS.

7. REGARDING PARA TWO REF A, STATION NOT AWARE COMMENT THIS SUBJECT IN GROUPS NOT ALREADY CONNECTED WITH AMLASH ONE. FROM HERE PROB-LEM SEEMS BE THAT AMLASH CIRCLE IS WIDE AND EACH NEW FRIEND OF WHOM

WE LEARN SEEMS TO HAVE KNOWLEDGE OF PLAN.
