

1. Augustin ALLES was employed under the AMHIM project at a salary of \$500/month, and also worked part time at \$200/month for Juana Castro's radio programs, until the AMHIM project was terminated on 30 May 1970. At that time, he began working full time as editor of Juana Castro's radio programs over WNYW at a salary of \$300 per month. He continues to receive a pay check from the Agency which is presently being funded through a notional cover firm out of New Jersey. Mr. Alles was witting of Agency sponsorship of AMHIM and is witting of Juana Castro's involvement with the Agency.
