**SUBJECT: Alleged CIA Involvement with Oswald**

2. Martin is from New Orleans and has on past occasions voiced a healthy contempt for Garrison and his shenanigans. This feeling was undoubtedly shared by his legal friend who, judging by this letter, now appears to have second thoughts.

I am enclosing headline copyright story which appeared in the afternoon States. I have absolutely no inside information as I have not even talked with George W. Healy, Jr., or anybody else with the paper about the Kennedy Assassination probe in a number of weeks. However, I know how superconservative the paper is and I think it is extremely significant that the powers that be are willing to go this far. From original skepticism, many people around town are beginning to think Jim might have something. In any event, I don't believe the C.I.A. can play ostrich much longer.
