8. My relations with Mr. have been very good, and i am inclined to believe what he says. However, this whole matter, of course, would have to be evaluated by the Clandestine Services.

There is one other matter I would like to mention in connection with Mr. \_\_\_\_\_\_and that is that he served for two and a half months with a group of Cuban fliers in the Congo, as he holds a pilot's license. He did not tell me and I did not ask who the sponsors of this group were or what their duties were. He did, however, mention a Colonel\_\_\_\_\_\_and a Mr. \_\_\_\_\_\_ I strongly suspect, of course, that this was an agency operation and, if so, the Clandestine Services will already have a good deal of information about Mr.
