Project HARVEST

1. Reference is made to your memorandum dated 6 October 1960 which requested this office to take appropriate action to attempt to intercept any letters sent from Cuba to the ostensible parents of the three persons presently imprisoned by Cuban authorities.

2. In the case of Mildred and Daniel CARSWELL, the notional parents of Daniel L. CARSWELL, their address as listed on his birth certificate is [REDACTED], Pennsylvania. Arrangements have been made to provide that any mail addressed to CARSWELL at [REDACTED] Pennsylvania will be re-directed to a post office box established and serviced by this office at Philadelphia, Pennsylvania. In addition, the names of his parents have been added as co-addressees of the backstopped live address originally established by this office for CARSWELL at Eastchester, New York. This address appears as his current residence address on his drivers license and other documentation.

3. Eustace and Gladys DANERUMT, 2955 Endora Avenue, Cleveland, Ohio, are listed as parents on the birth certificate carried by Eustace J. DANERUMT. It has been determined that there is no Endora Avenue in Cleveland, though there is an Endora Road. However, house numbers on Endora Road run only from 16500 to 17820. Arrangements have been completed to provide that any mail addressed to DANERUMT at Endora Avenue or Endora Road will be intercepted and delivered to a representative of this office.

4. DANERUMT's drivers license and other documentation list 3915 Polfield Avenue, Baltimore, Maryland as his current address. An empty apartment has been listed in the name of DANERUMT at this address, which can be retained only until such time as the management obtains a permanent tenant under a long-term lease. It may be expected that the apartment will be rented during the next month, at which time arrangements will be made to forward any mail for DANERUMT or his parents to a post office box established and serviced by this office at Baltimore, Maryland.

5. Concerning Walter and Anna TARASKEY, the national parents of Edmund K. TARASKEY, his birth certificate indicates they resided at 54 Glenville Avenue, Boston, Massachusetts. There is no number 54 on Glenville Avenue in Boston. The site is occupied by apartment houses, none of which is numbered 54. Arrangements have been made to provide that any mail addressed to TARASKEY or his parents at Glenville Avenue will be re-directed to a post office box established and serviced by this office at Boston, Massachusetts.

6. The address 509 West 77 Street, New York City, appears on TARASKEY'S documentation as his current address. A vacant apartment has been rented in TARASKEY'S name at this address through 31 October 1960, and mail addressed to him or his national parents will be accepted. If it is decided that the apartment should be retained after 31 October 1961, this office should be provided with an allotment number to cover additional rental payments, which will be approximately one hundred and forty dollars (\$140.) per month. If retention of the apartment in TARASKEY'S name is considered unnecessary, this office will arrange a forwarding procedure to re-direct any mail to a post office box at New York City, upon advice from your office.

7. In response to your inquiry as to what disposition would normally be made of foreign mail which is undeliverable because of an incorrect address, you are advised that local post office stations will make no attempt to determine if there is a local correct address for the addressee by checking local directories, as they will do with mail of domestic origin. Foreign mail which is incorrectly addressed is considered "undeliverable", and is returned to the country of origin, with no attempt to determine the correct address.

8. In accordance with the request contained in paragraph two of your referenced memorandum, the following post office address has been established for your use:

9. This address will be serviced on a once weekly basis, until advice is received from your office indicating that servicing should be increased. Your office will be notified upon the receipt of any mail through this post office box, or through any of the arrangements made at Boston, New York, Cleveland, [redacted] or Baltimore.
