1. REQUEST STATION HAVE MRS. DIAZ APPLY FOR IMMIGRATION VISA. CASE OFFICER SHOULD ACCOMPANY HER TO APPOINTMENT. NO OBJECTION REVEALING OPERATIONAL INTEREST TO CONSUL. HQS ARRANGING OBTAIN AFFIDAVIT OF SUPPORT FROM U.S. BUSINESSMAN THROUGH MIAMI REPRESENTATIVE, WHICH TO BE MAILED DIRECTLY. REQUEST ADDRESS TO WHICH AFFIDAVIT MAY BE SENT.

3. IF CONSULATE RELUCTANT GRANT VISA, REQUEST IT CALL DEPT FOR ADVISORY OPINION. IF ADVISORY OPINION SOUGHT, STATION CABLE HQS

SIMULTANEOUSLY PERMIT PROMPT KUBARK APPROACH TO DEPT.
