2. IN VIEW OF REF [REDACTED], BELIEVE DECISION WHETHER [K-1] SHOULD INFORM MADRID DIRECTOR OF BERLITZ OF HSCA REQUEST IS ONE BEST LEFT TO DISCRETION OF [K-1]. IN ORDER TO ASSIST [K-1] IN MAKING HIS DECISION, REQUEST [REDACTED] INFORM [K-1] OF THE ADVERSE REACTION TO THE PUBLICITY AFFECTING [K-1] REPORTED REF [REDACTED] AND OBTAIN HIS VIEWS. PLEASE ADVISE HIS REACTION AND ALSO IF HE ANTICIPATES WHETHER HE FORESEES ANY PROBLEM IN TAKING LEAVE.

2. RE PARA 2 OF REF A, BELIEVE IT BETTER FOR ALL CONCERNED IF STATION CAN INDUCE [K-1] TO COME TO STATES FOR INTERVIEW. ASSURE [K-1] THAT USG WILL PAY ALL EXPENSES INCURRED. IF [K-1] RECEPTIVE TO TRAVEL TO U.S., PLS OBTAIN HIS VIEWS ON TIMING OF TRIP. IF [K-1] BALKS AT HOLDING MEETING IN U.S., WILL EXPLORE WITH HSCA POSSIBILITY OF MEETING ELSEWHERE IN EUROPE.

PASSPORT. FURTHER THAT ACCORDING TO [REDACTED] LATIN⁰²S ARE ABLE TO APPLY FOR CITIZENSHIP AFTER COMPLETION OF TWO YEARS RESIDENCE IN SPAIN. BY [REDACTED] 17219 (11 SEPT 1972), STATION REPORTED THAT [K-1] HAD CONTACTED THE CONSULATE ON 11 SEPTEMBER TO EXPLAIN REASON [REDACTED] UNTIL HIS SPANISH RESIDENCE ESTABLISHED, WHICH WOULD BE APPROXIMATELY THREE MONTHS AFTER HIS ARRIVAL IN SPAIN. MOST RECENT INFORMATION IN HQS FILES ON [K-1]'S CITIZENSHIP IS [REDACTED] 18039 (5 JANUARY 1973) WHICH REPORTED THAT [REDACTED] WAS OF THE OPINION THAT THERE WAS NO PROBLEM IN DOCUMENTING [K-1] AS "STATELESS" ON THE BASIS HE "LOST" HIS [REDACTED] DOCUMENTS, AND THAT [K-1] SHOULD REPORT TO THE [REDACTED] 02
