MEMORANDUM FOR: Chief, SAS (Provisional) *Hillary, Bernard*
 ATTENTION : Mr. George Ladner
 SUBJECT : Military Documentation
 REFERENCE : Memorandum, Request for Military Documentation
 in Alias, Dated 8 May 1963.

1. HR 240 has designated the Central Cover Staff as the responsible office for issuance and control of cover documentation. To discharge this responsibility, CCS has made special arrangements with the Department of the Army to approve and backstop a credential which is unique to a military unit.

2. This [redacted] ²⁴ is unique to our cover units, as within the Department of the Army this type of a credential is issued only to accredited investigators of the [redacted] and the [redacted]. ³² Therefore, it is incumbent upon all Agency components to utilize this document only when operationally necessary and under careful supervision.

3. By agreement with the Department of the Army, these credentials are to be used under the following conditions:

a. PURPOSE: These documents are to be used as "flash" identification only when making initial operational contacts.

b. COVER STORY: These documents are issued by the US Army Element, [redacted] with Headquarters in the Pentagon, Washington 25, ³² D.C., telephone Oxford [redacted]. Each individual must be briefed thoroughly on the cover unit. Individuals not briefed on the cover unit prior to the issuance of these credentials should be instructed to report to MCB/CCS as soon as possible for a briefing.

c. COVER LIMITATIONS: The [redacted] will always be used in conjunction with the DA Form 1602. It will be used for operational purposes only ²⁴ and never for personal identification.
