THE ARTICLE, ORIGINATING WITH PRENSA LATINA, RELATES THE ACTIVITIES OF [ ] RODRIGUEZ CALLEGO] WHEN HE LIVED AT [CALLE FRANCISCO MARQUES 149-1, [ ] IN MEXICO CITY AND TOOK PHOTOGRAPHS OF VISITORS TO THE CUBAN EMBASSY AND ALSO PARTICIPATED IN ELECTRONIC OPERATIONS AGAINST THE CUBAN EMBASSY AND CONSULATE. IN 1972, [ ] WAS "DEACTIVATED" AND WENT TO SPAIN WHERE HE BOUGHT AN APARTMENT ON AVENUE DEL MANZANARES 1947-A (MADRID 26) WHERE HE NOW LIVES. THE ARTICLE ALSO LISTS TWO OF HIS FORMER CIA CASE OFFICERS AND PROVIDES OTHER BACKGROUND INFORMATION ON HIS ACTIVITIES IN CUBA BEFORE HE WENT TO WORK FOR THE CIA.
