Miss RONSAVILLE stated that an unofficial transcript was given to Barbara TARASOFF in June 1963, which reflects her father's employment as analyst, U.S. Government (no address given). This transcript does not reflect her mother's employment.

Miss RONSAVILLE advised that to date, no official transscripts have been issued to, or on behalf of Barbara.
