The material obtained from the Immigration and Naturalization Service pertaining to Lee Harvey OSWALD's spouse Marina was provided to Mr. ⁰³ [redacted] in the office of Mr. Birch O'Neil, CI Staff, on 27 November 1963 with the understanding that it would be returned to the Office of Security when CI Staff is finished with it.

On 23 January 1964, Mr. ⁰³ [redacted] advised that they are still using the material; however, they intend to return it to the Office of Security when they have finished their interest.

All material numbered 75 149 - 625, in the name of Marina N. OSWALD, has been transferred to the file of Lee Harvey OSWALD, #351 164, with the exception of the material in the possession of the CI Staff, which, when returned, will be placed in #351 164 also.
