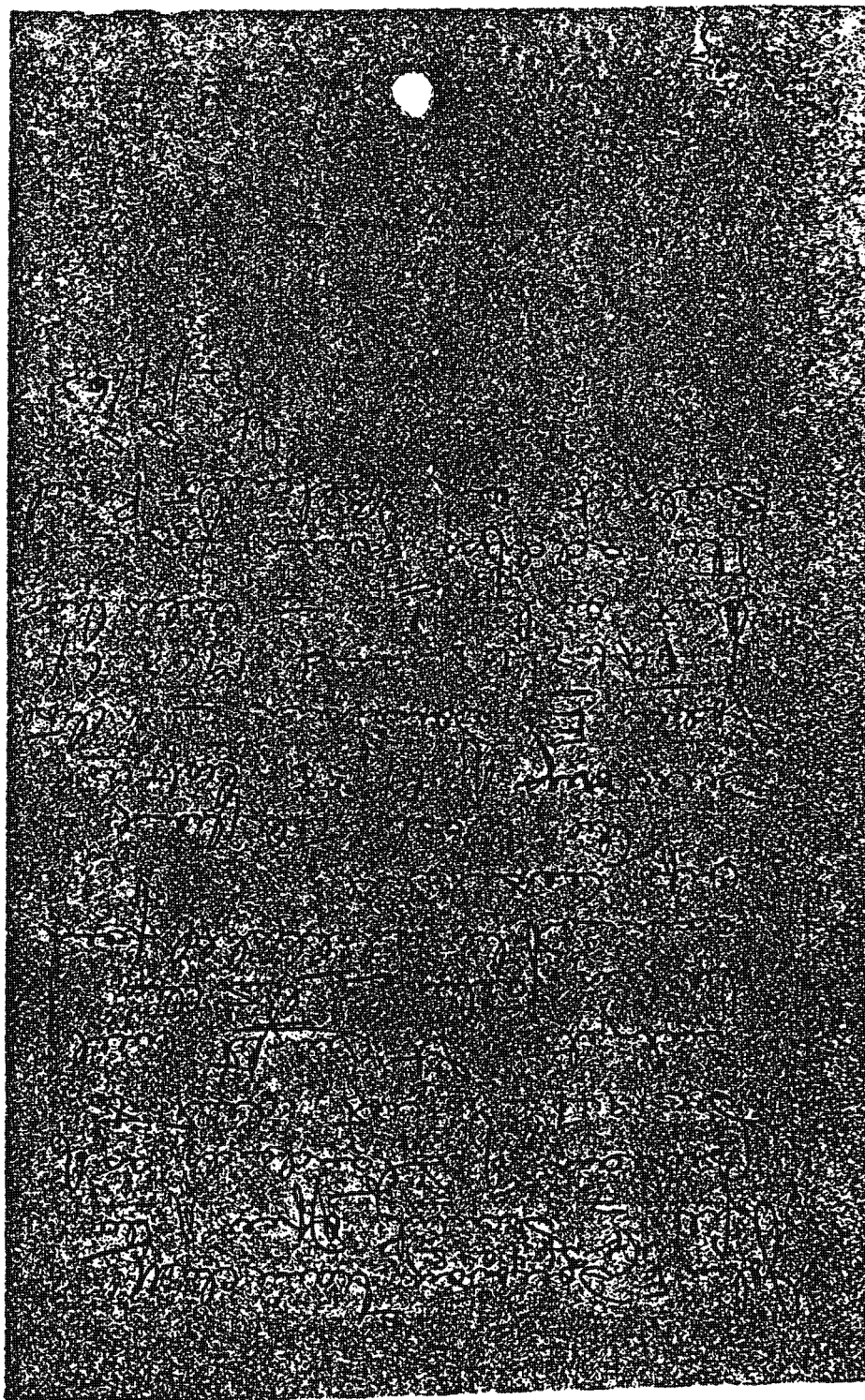

SUMMARY OF INFORMATION: Donovan called to report that he knew and worked with Lee Harvey Oswald for a nine month period while fulfilling his military obligation in the Spring, Summer and Fall of 1959. Donovan advised he may possibly be of assistance in providing names and etc. of Oswalds intimate acquaintances during that period. Subject further advised that he has not discussed his knowledge of Oswald with the FBI or the Secret Service as of this time. Donovan is presently attending Georgetown University while teaching at Ascension Academy. He may be contacted any evening after 6:00 P.M. at the above address. Donovan related that he is a former FBI employee having worked there from June 1953 to 1956. It is also noted that advance knowledge of this call was received from NSO John Moretti and Major A. F. Boland, Agency employees, who are both members of Capt. John E. Donovan's USMCR unit.

ACTION TAKEN: Contacted Charlie Kane, OS, who requested that this report be prepared and submitted so that the lead may be turned over to the FBI through official channels.
